INTRODUCTION

Literacy is an inseparable part of human life. Literacy is a competency that should be developed individually and adapted to the times. The definition of literacy includes: (1) a series of skills in speaking, reading, calculating, using information as well as writing skills, (2) a practice whose implementation uses context, (3) one of the learning activities accompanied by reading, writing as a way to criticizing knowledge, pondering, investigating ideas that have been studied, (4) literacy is identical with a text that has variations in language, genre, and subject complexity. Literacy itself also has a definition of an individual's ability to understand, as well as to use information wisely and intelligently. Literacy should indeed be an awareness for all levels of Indonesian society, because literacy can certainly prepare a superior and quality society.

Indonesian society until now still has a culture of literacy that can be said to be low. Based on UNESCO statistical data, the Indonesian state scored surprising results, out of 1000 people, there was only 1 person who had a high reading interest. Worse still, Indonesian people do not read more than 2 to 3 books every year.

According to Utami (2021), Indonesia has many problems related to the low interest in reading. This is reinforced by the results of the Program for International Student Assessment

(PISA) survey on literacy conducted in 2019, showing that Indonesia is ranked 62 out of 70 countries. Indonesia is certainly included in the 10 countries with low literacy. According to UNESCO standards, the ideal reading time in a day is 4 to 6 hours. For developed countries, literacy culture is 6 to 8 hours a day. However, for Indonesia itself the culture of reading is only 2 to 4 hours a day (Winarni, 2019).

The development of technology will certainly make the interest in reading or literacy of the Indonesian people lower. Various applications will attract the attention of the public because they can be accessed anytime and anywhere without taking a long time. Ease of accessing all forms of information will spoil the community so that people will more easily depend on technology than books. According to Fitriani., & Aziz. (2019), Indonesian people certainly do not have to depend on technology constantly, but Indonesian people must be able to use technology as an effort to improve and develop a literacy culture.

Increasing literacy among the community will certainly make people get much more accurate information and avoid hoaxes. And indirectly people will become accustomed to choosing valid information and not easily influenced by the information produced by the media. Various socializations have been carried out, but literacy in Indonesia has not become a culture. This is because people prefer to get instant information from technology rather than having to open books one by one.

This article aims to find out what are the impacts and causes of the low literacy movement of the Indonesian people, as well as to find out how to empower the literacy movement among the people in the era of society 5.0.

The contents of our article review are related to the condition of people's reading interest in Indonesia. The habit of reading in society certainly does not appear without a cause, but the habit arises through a series of continuous learning processes. The habit of reading, of course, must begin to be instilled in the golden age, because at this time it will be easier to form character. Low public interest in reading will make Indonesia even more lagging behind other countries (Anisa., Ipungkarti., & Saffanah, 2021)

Factors and consequences of low literacy

Factors from the environment of course also trigger low literacy among Indonesian people. These factors include: 1) The existence of technological developments in the form of technology broadcasts that present various shows so that they are more attractive to the public, 2) Excessive use of smartphones and internet connections causes people to be less interested in reading books, 3) Families do not implement mandatory reading activities at home. This of course will make children have low literacy skills, because basically children will imitate the habits of their parents. 4) Indonesian people think that books are not important and books are not a necessity, 5) there are no facilities and infrastructure for reading gardens in the community (Witanto, 2018). The low interest in reading in the community will of course have an impact that exacerbates the problem of reading interest.

As a result of the low interest in reading the community will affect the quality of the Indonesian people who are less able to compete in the era of society 5.0. According to Anisa., Ipungkarti., & Saffanah. (2021), the impact that will occur if Indonesian people still have low reading interest will be detrimental to themselves. This is because due to the low interest in reading, it will cause various problems in mastering, understanding and not being able to use technology properly which will affect the lack of positive ways of thinking so that they are prone to experiencing doctrine. In addition, the low interest in reading makes the creativity of the Indonesian people not develop, and they experience obstacles in improving their quality. Worse yet, people will tend to close themselves off, not being able to communicate well, at the same time the country will lose a quality young generation who can advance the nation.

The importance of literacy

Literacy skills are not just having the ability to read and write, but also have the ability to use technology, think critically, and be sensitive to the environment. Someone who has good literacy is needed by this nation to be able to compete with other nations. According to Suragangga (2017), in Indonesia literacy is still not a culture that must be carried out by the community but is still considered as a necessity. Whereas literacy skills are very important for success in a society because with good literacy skills it can help the community in understanding various existing information both verbally and in writing. In addition, with literacy skills, the community will not only get good and correct information, but can also document their experiences for the future. Literacy can make humans can function optimally in their social environment. This is because,

with good literacy skills, someone can be able to solve problems by thinking critically. In addition to critical thinking, with good literacy skills, people will be able to communicate, collaborate, and be creative and innovative in the surrounding environment.

If people's literacy skills are low, it can easily cause problems in the community. An example that we can see directly is that people easily believe false information without thinking critically about the source and truth of the information. In addition, people also do not read the information in depth, which sometimes leads to misunderstandings which eventually lead to conflict. Based on this example, it is necessary for the community to improve their literacy skills. Literacy empowerment

In addition, literacy socialization to the community is carried out to see the effectiveness of this activity if it is carried out by the community in an area. Herdiana (2018), explained that in the implementation of this literacy movement, it must come from the needs of the community because in this activity it will be directly related to the daily life of the community. Therefore, by collaborating with FWT members and several related parties, the literacy movement can run well and in accordance with the conditions in an area.

Socialization of the literacy movement with children

Socialization of the literacy movement aimed at children can be done by inviting them to learn and play together. Learning and playing activities can be carried out in a suitable and comfortable place. Irianto., & Febrianto. (2017), stated that children in the learning process will need various kinds of references for their knowledge. Therefore, the existence of this literacy movement makes it a necessity and a culture that can provide benefits for children. Today's children do not use various reading sources to increase their knowledge.

The rapid development of technology is often used by children for useless activities such as playing online games or accessing social media. Whereas children can use the internet to obtain information and knowledge as a learning resource. The use of the wrong information technology can cause a decrease in children's interest in learning, children will become addicted, unable to filter out false information. This is due to the lack of providing appropriate and appropriate teaching to children. Socialization of the literacy movement by reading and playing with children can help children increase their interest in reading and learning. In addition, children can use technology well and can avoid problems due to lack of literacy skills.

Creating a reading garden

In this literacy movement, reading gardens are indispensable for the community. This reading park can be used by the community to obtain various information and can also build values in life (Alam, 2015; Rohman., & Sukaesih, 2017; Yusup., & Saepuddin, 2017). The reading garden can be placed in a very strategic place making it easier for people to visit it. Reading gardens for various villages in Indonesia are still not available because they are considered less important for the community. In fact, reading gardens are very important in their area to be able to increase knowledge and information. As for the areas that already have a reading garden but have some problems. The problems that exist are related to the limited number of books available, the types of books that are less varied, the condition of the reading gardens that are not maintained, the remote locations making it difficult for the public to access, and other problems. In addition, the management of the reading park does not promote the existing reading garden to the public.

CONCLUSION

The public literacy movement in Indonesia is in the low category, resulting in changes in lifestyle, a culture that tends to imitate the western lifestyle, and the disappearance of a sense of nationalism while making most Indonesians easily influenced by hoax news. This is triggered by the development of science and technology which makes people less wise in using existing technology, less applying reading habits for children, books are considered to be unnecessary items, and the movement for reading is not balanced with adequate facilities and infrastructure. Literacy skills are very important for success in a society because with good literacy skills it can help people understand various existing information, both oral and written. If people's literacy skills are low, it can easily cause problems in the community.Therefore, there is a need for high literacy awareness in the community to be able to encourage and educate other people so as to make literacy a culture and a necessity in life.
